Parents/Guardians are advised that:

- The St. James Catholic Global Learning Centre is an **optional program** for students in grades FDK to Grade 8.
- There is **no transportation** (busing) to St. James CGLC.
- As a program of choice with limited enrolment, the Board practice of random selection to determine eligibility will apply should applications received by the registration deadline exceed available student places.
- Siblings of students currently in the program would also be part of the random selection and are not automatically guaranteed a pupil place to ensure equity of access to the regional program.
- Twin siblings will each submit an application per sibling and are not guaranteed a pupil place to ensure equity of access to the regional program.
- A waitlist for the current school year will be maintained should pupil place become available during the year.
- If a spot becomes available, the school will contact the applicant and said applicant will have 48 (forty-eight) hours to accept the spot. After 48 (forty-eight) hours, the school will contact the next applicant on the waitlist.
- Students must be eligible to enroll in a Roman Catholic School (i.e., either one parent or the child has been baptized in a Church recognized by the Holy See of Rome).

 - Baptismal Certificate (*parent, child or both*)
 - Birth Certificate
 - Immunization Record/Registration number

 - Application of Direction of School Support (GF 005)
 - Separate School Lease GF006P (if one parent/guardian is non-Catholic)
